(a) Paul Champagne informed the Board that the invoices have been reviewed and he recommends that the invoices for the month be paid.

#### **Agenda Item No. 12:** Bill Neef (Neef Engineering)

- (a) Neef provided the Board with a copy of the Operations Budget through June 2025 and outlined same for the Board.
- (b) Neef provided the Board with a copy of the CIP Budget through June 2025 and outlined same for the Board.
- (c) Neef informed the Board as to a billing error with regard to the totalizer meter on Fieldspan. In April of 2025, LUS replaced the totalizer meter located on Fieldspan and, in doing so, discovered that for the past twenty-nine (29) months, the meter had been underread which significantly

impacted the amount LUS was billing LPWDN. LPWDN owes LUS a total of \$224,305.15 which will be paid to LUS on a monthly basis at \$7,734.67 per month for twenty-nine (29) months.

Neef informed the Board that there are three broken master meters in the area that will impact LPWDN's billing to Magnolia Water. Neef is in the process of reviewing and calculating the water used by Magnolia.

Neef informed the Board that the audit has been completed and that the auditors will be at the LPWDN Regular Board Meeting in July to present findings on same.

# **Agenda Item No. 13:** Byron P. Guillory (Chief Administrative Officer / Legal Counsel)

- (a) Guillory informed the Board of a proposal from LCG regarding an amendment to LPWDN fire hydrant agreement with LUS/LCG. Guillory indicated that further information needs to be reviewed on this matter and that he recommends that same be deferred to the committee.
- (b) Guillory recommended that the Board consider a merit increase for Kevin Scanlan in the amount of \$1.00 per hour.

A Motion was offered by Robert Marceaux, seconded by Jared Richard, approving a \$1.00 per hour merit increase for Kevin Scanlan. The Motion was unanimously approved.
